32. Kylie made a motion, second by Kim to adjourn the monthly meeting. Motion carried.


Oath of Office


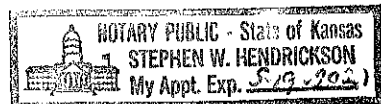
