

Hanover City Council Meeting

June 8, 2020 at 6:00pm

The regular Hanover City Council meeting was held June 8, 2020 at 6:00pm in the meeting room at the Firehouse at 201 S Railroad Street Hanover KS 66945.

Mayor Jared Sedlacek called the meeting to order at 6:00pm. Council members were Tony Bruna, Nick Rohr, Kim Lohse, Kylie Fritschi and Don Spencer. Employees present were Tim Koss, Scott Wieden, and Katlin Bruna. Guest were Robert Rut, Fire Chief, Markus Frese, CPA, and Jon Pralle.

1. Don made a motion, seconded by Kim to approve the May monthly treasurer report. Motion carried.
2. Tony made a motion, seconded by Kylie to approve the May monthly expenses. Motion carried.
3. Tony made a motion, seconded by Don to approve the May regular meeting minutes and the two special meeting minutes. Motion carried.
4. Robert Rut, Fire Chief, reported for the month of May they only had one call; the fire truck has been fixed and pump tested; the fire department is going to apply for a grant through the Coop to update their gear and air tanks; and they will be doing some cleaning and testing of the fire hydrants.
5. Markus Frese, CPA, discussed the 2021 budget with the council; gathering information and thoughts to get everything prepared for August.
6. Jon Pralle, Hanover resident, discussed the speeding and condition of East street.
7. Street Department
 - a. The council discussed thoughts about the what they would like to do for grants for the roads in the city limits.
 - b. Tim Koss stated that the City of Washington will not be sealing streets this year due to their own water project and will not be able to help the City of Hanover when they start to seal streets.
8. Water Department
 - a. The council discussed going forward with having an inspection done on the city pool
 - i. Nick made a motion, seconded by Don to have Paddock Pool do the inspection and design of the city pool for \$7500.00. Motion carried.
 - b. The council discussed what to do for pool concessions and it was decided that they would sell bottled water only at the pool for the 2020 season.
 - c. Lifeguard Application
 - i. Nick made a motion, seconded by Don to approve hiring Tianna Lohse as a lifeguard a for the 2020 pool season. Motion carried.
 - d. Kim made a motion, seconded by Kylie to approve ordering supplies needed for the pool including two rescue tubes, a ring buoy, and a first aid kit. Motion carried.
9. Parks and Rec
 - a. The council discussed maintenance to the tennis courts at Vet's Park. Tabled for pricing research.
 - b. The council discussed getting new basketball goals for the tennis courts at Vet's Park and the City Park. Tabled for pricing research.
 - c. The council discussed adopting bylaws for parks and rec. Tabled.
10. Grants and Funding

- a. Tony made a motion, seconded by Don to approve the following forms for the water project from USDA; form RD 1910-11, Right-of-Way Certificate, RD 442-21, and KS 1780 Guide 24. Motion carried.

11. City Office

- a. The council discussed having American Legal help organize the city ordinances. Tabled for pricing research.
- b. The council discussed recent complaints about bikes and ATV/UTV/Golf Carts around the city.

12. Buildings and Properties

- a. The council discussed the progress of the A/C and maintenance at the Community Building.
- b. The council discussed the project at the football field in regard to the fencing and designated a committee including Jared and Nick.
