

Hanover City Council Meeting

September 14, 2020 at 6:00pm

The regular Hanover City Council meeting was held September 14, 2020 at 6:00pm in the meeting room at the Firehouse at 201 S Railroad Street Hanover KS 66945.

Mayor Jared Sedlacek called the meeting to order at 6:00pm. Council members were Tony Bruna, Nick Rohr, Kim Lohse, Don Spencer, and Kylie Fritschi. Employees present were Tim Koss, Scott Wieden, and Cami Bruna. Guests included Robert Rut, Fire Chief, and Kyla Schlabach

1. Don made a motion, seconded by Kylie to approve the monthly treasurer report. Motion carried.
2. Kylie made a motion, seconded by Don to approve the monthly expenditures. Motion carried.
3. Don made a motion, seconded by Kim to approve the minutes. Motion carried.
4. Fire Chief, Robert Rut, reported that the gutters at the Firehouse are still leaking in some spots; Weis Fire will be sending bills for the fire department and will need to be paid right away; and that the Fire Safety Day for the schools is being postponed until Spring.
5. The council discussed the letter that Jason Brinegar, city attorney, wrote up to send to Fisher Rock regarding the broken rock for the Firehouse.
 - a. Don made a motion, seconded by Kim to approved sending the letter. Motion carried.
6. Kyla Schlabach asked the council for permission to use main street for a ball drop fundraiser for March4Life on October 8th and asked that side streets could be barricaded. The council approved this.
7. Grants&Funding

8. The council reviewed the sealed bids that were turned in for the projects of the School Parking Lot, City Shop repairs, and Library repairs.
 - a. There were no School Parking Lot bids turned in.
 - b. There was one bid for the City Shop repairs.
 - i. Kevin Bruna Construction bid for \$11,035.00.
 1. Tony made a motion, seconded by Kim to accept the bid with contingency on bid for replacing the lights that they would discuss with Kevin. Motion carried.
 - c. There was one bid for the Library Repairs.
 - i. Rohr the Handyman bid for \$18,325.00
 1. Tabled to next meeting.
9. Buildings & Properties
 - a. Community Building
 - i. The buildings and properties committee discussed what was all discussed at the meeting with the Chamber members.

- ii. Council is wanting to get together with the Chamber to see what projects and repairs need to be done at the community building.
