With winter comes snow...here are a few reminders for when the snow decides to arrive! Below is a reference for Ordinance #688—ESTABLISHING SNOW REMOVAL RULES AND PROCEDURES FOR THE STREETS.

Emergency Snow Routes—Upon announcement by the City that the "Snow Removal Regulations" are in effect, the streets listed in this section shall be designed as "Emergency Snow Routes". No parking shall be allowed and violating vehicles shall have violation notices placed thereon.

- ⇒ North Street from Highland Haven to Wulff Street
- ⇒ All of North Denver Avenue
- ⇒ All of South Denver Avenue
- ⇒ East Street from 23<sup>rd</sup> Road to East Washington Street
- ⇒ Kansas Street from South East Street to South Hanover Street
- ⇒ Hanover Street from East Kansas Street to East North Street
- ⇒ Washington Street from East Street to South Bern Street
- ⇒ Bern Street from North Street to Washington Street
- ⇒ Church Street to North Street to Washington Street
- ⇒ Jaedicke Street from Church Street to Railroad Street

**Primary Snow Routes**—upon accumulation of snow depth of three inches (3"), the "Snow Removal Regulations" are in effect and the following streets shall be designed as "Primary Snow Routes" and vehicles are requested to be removed.

- ⇒ All of Elm Street
- ⇒ All of Highland Street
- ⇒ All of Railroad Street
- ⇒ Bern Street from North Street to Elm Street
- ⇒ All of Center Street
- ⇒ All of Harbine Street
- ⇒ All of South Street
- ⇒ All of Hill Street
- ⇒ All of North Ridge Terrace
- ⇒ All of Hilltop Drive
- ⇒ East Street from Washington Street to South Street
- ⇒ Church street from Elm Street to North Street and Jaedicke Street to South Street
- ⇒ Hanover Street from Farrell Street to North Street from Kansas Street to South Street
- ⇒ Jaedicke Street from East Street to Church Street and Railroad Street to South Denver Avenue
- ⇒ Washington Street from Bern Street to South Denver Avenue
- ⇒ All of Farrell Street
- ⇒ All of Kensington Place, West Minster, and Belgrave Avenue
- ⇒ All of Jackson Street



Fall is HERE which means WINTER is coming!! With winter comes snow...here are a few reminders for when the snow decides to arrive! Below is a reference from Ordinance #687—SNOW REMOVAL ON PRIVATE PROPERTY.

- Section 1. SNOW AND ICE TO BE REMOVED.
- (a) It shall be unlawful for the owner and/or the occupant of any lots abutting upon any sidewalks to fail to cause to be removed from such sidewalks all snow and ice within 12 hours from the time that the snow fall or ice storm ceases. If the snow falls or ice accumulates upon the sidewalks in the nighttime, removal of same must be made within 12 hours after sunrise on the following day.
- (b) It shall be unlawful for any person to place snow removed from private property upon any public street, alley or sidewalk.
- Section 2. SAME: EXCEPTION; ALTERNATE REMEDY. Where there shall be ice or compacted snow on any such sidewalk of such a character as to make it practically impossible to remove the same, the sprinkling of ashes, sand or other noncorrosive chemicals on the accumulation of ice or snow in such a manner as to make such sidewalk reasonably safe for pedestrian travel shall be deemed a sufficient compliance with the provisions of this ordinance until the ice or snow can be removed.
- Section 3. SAME; PENALTY. That any person violating the provisions of Section 1 shall, upon conviction, be fined \$25, plus court costs for the first offense. Additional convictions shall cause the fine to be doubled from the previous fine (2<sup>nd</sup> offense \$50, third offense \$100, etc.)
- Section 4. REMOVAL MAY BE MADE BY CITY. If any owner or occupant of any lot or lots shall refuse or neglect to clean or remove from the sidewalk abutting the lot or lots all snow and ice within the time specified, the city may cause such snow and ice to be removed from sidewalks and the cost thereof shall be assessed against such abutting lot or lots, and the city clerk shall certify the same to the county clerk for collection as provided by law.



#### **History of our Veterans**

A history project started in 1985 at the Hanover American Legion Post 306, when Maxine Koehler was Auxiliary Historian; along with Max Melchers , Historian of Post 306; Russ Behrends, Commander; and Ellen (Sue Tyson) Meyn, Auxiliary President. The history book was first presented to the public as one large hard covered book of information and through the efforts of Maxine and many others it has grown to three large books and still increasing.

In memory of Carl Koehler, a Korean Conflict Veteran, his wife Maxine and their family have donated a video presentation and interactive touch screen to the newly remodeled Flag Display Room at Post 306 American Legion. The video consists of the information compiled in the books and is set to patriotic music. The video is played on an interactive touch screen, allowing viewers to move through the video to find veterans of their interest in alphabetical order. It contains information to date of more than 680 area veterans and active military who serve to preserve our freedom. We encourage you to visit the Legion and view this project.
