

Hanover City Council Meeting
November 10, 2021 at 6:00pm

The Hanover City Council meeting was held November 10, 2021 at 6:00pm in the meeting room at the Firehouse at 201 S Railroad Street Hanover KS 66945.

Mayor Jared Sedlacek called the City of Hanover council meeting to order at 6:00pm. Council members present were Kim Lohse, Nick Rohr, Don Spencer, Kylie Fritschi and Tony Bruna. Employee's present were Katlin Bruna, Tim Koss, Scott Wieden and Melissa Minge. Guests included Robert Rut, Fire Chief.

1. Treasurer Report
