NEWS FROM THE HANOVER HOSPITAL

Did you know that every 3 seconds someone in the world develops dementia?

Did you know that smoking, alcohol use, diabetes, and high cholesterol levels are risk factors for dementia? Did you know that there are brain scans that can detect Alzheimer's-related changes in the brain before memory loss is evident?

Please join us for an evening of learning about dementia. It will be held on January 26th at 6:00 PM at the Kloppenberg Center.

Recently, the Hanover Hospital has partnered with the University of Kansas' Cognitive Care Network (CCN). The speaker for the evening will be Hanover Hospital's CCN Navigator, Cindy Miller. Cindy is a nurse who has been working with individuals with all types of dementias as well as their caregivers since 1989. She was the director for the State of Kansas' Alzheimer's Aging Specialists as well as the dementia care coordinator for the Alzheimer's Association, Heart of America Chapter.

The goal of the CCN program is to provide rural communities with resources to help minimize patients' symptoms of dementia and maximize their quality of life. The program is geared toward providing education and support to patients living with the disease, as well as their families and caretakers. Our goal at the Hanover Hospital is to work with Cindy and KU's Cognitive Care Network resources to make the cognitive impairment diagnosis early to help our patients live at home as independently and as safely for as long as possible.

Please keep in mind, you do NOT have to be a patient of ours to attend this event. You do not need a referral to meet with our Cognitive Care Network Navigator either. WINTER IS HERE!! With winter comes snow...here are a few reminders for when the snow decides to arrive! Below is a reference for Ordinance #688— ESTABLISHING SNOW REMOVAL RULES AND PROCEDURES FOR THE STREETS.

Emergency Snow Routes—Upon announcement by the City that the "Snow Removal Regulations" are in effect, the streets listed in this section shall be designed as "Emergency Snow Routes". No parking shall be allowed and violating vehicles shall have violation notices placed thereon.

- ⇒North Street from Highland Haven to Wulff Street
- \Rightarrow All of North Denver Avenue
- ⇒All of South Denver Avenue
- ⇒East Street from 23rd Road to East Washington Street
- ⇒Kansas Street from South East Street to South Hanover Street
- ⇒Hanover Street from East Kansas Street to East North Street
- ⇒Washington Street from East Street to South Bern Street
- ⇒Bern Street from North Street to Washington Street
- ⇒Church Street to North Street to Washington Street
- ⇒Jaedicke Street from Church Street to Railroad Street

Primary Snow Routes—upon accumulation of snow depth of three inches (3"), the "Snow Removal Regulations" are in effect and the following streets shall be designed as "Primary Snow Routes" and vehicles are requested to be removed.

- ⇒All of Elm Street
- ⇒All of Highland Street
- ⇒All of Railroad Street
- ⇒Bern Street from North Street to Elm Street
- ⇒All of Center Street
- ⇒All of Harbine Street
- ⇒All of South Street
- \Rightarrow All of Hill Street
- \Rightarrow All of North Ridge Terrace
- ⇒All of Hilltop Drive
- ⇒East Street from Washington Street to South Street
- ⇒Church street from Elm Street to North Street and Jaedicke Street to South Street
- \Rightarrow Hanover Street from Farrell Street to North Street from Kansas Street to South Street
- \Rightarrow Jaedicke Street from East Street to Church Street and Railroad Street to South Denver Avenue
- \Rightarrow Washington Street from Bern Street to South Denver Avenue
- \Rightarrow All of Farrell Street
- \Rightarrow All of Kensington Place, West Minster, and Belgrave Avenue
- ⇒All of Jackson Street



WINTER IS HERE!! With winter comes snow...here are a few reminders for when the snow decides to arrive! Below is a reference from Ordinance #687— SNOW REMOVAL ON PRIVATE PROPERTY.

•Section 1. SNOW AND ICE TO BE REMOVED.

(a) It shall be unlawful for the owner and/or the occupant of any lots abutting upon any sidewalks to fail to cause to be removed from such sidewalks all snow and ice within 12 hours from the time that the snow fall or ice storm ceases. If the snow falls or ice accumulates upon the sidewalks in the nighttime, removal of same must be made within 12 hours after sunrise on the following day.

(b) It shall be unlawful for any person to place snow removed from private property upon any public street, alley or sidewalk.

- •Section 2. SAME: EXCEPTION; ALTERNATE REMEDY. Where there shall be ice or compacted snow on any such sidewalk of such a character as to make it practically impossible to remove the same, the sprinkling of ashes, sand or other noncorrosive chemicals on the accumulation of ice or snow in such a manner as to make such sidewalk reasonably safe for pedestrian travel shall be deemed a sufficient compliance with the provisions of this ordinance until the ice or snow can be removed.
- •Section 3. SAME; PENALTY. That any person violating the provisions of Section 1 shall, upon conviction, be fined \$25, plus court costs for the first offense. Additional convictions shall cause the fine to be doubled from the previous fine (2nd offense \$50, third offense \$100, etc.)
- •Section 4. REMOVAL MAY BE MADE BY CITY. If any owner or occupant of any lot or lots shall refuse or neglect to clean or remove from the sidewalk abutting the lot or lots all snow and ice within the time specified, the city may cause such snow and ice to be removed from sidewalks and the cost thereof shall be assessed against such abutting lot or lots, and the city clerk shall certify the same to the county clerk for collection as provided by law.


